Frequently Asked Questions:

What is our philosophy?

We approach each case from a scientific point of view by attempting to find reasonable explanations for each and every claim. By eliminating what is not paranormal first, we can concentrate our efforts on the evidence that is unexplainable.

Do we charge for an investigation?

We will never charge anyone for an investigation. Although there are significant costs associated with conducting an investigation, our appreciation for the opportunity to investigate someone's home or business is payment enough.

How can I join your group?

TSRG is always looking to expand our group. If you would like to be considered for membership, please call or email us with your information. We will provide you with an application, which will start the process.

What can I expect from TSRG during an investigation?

Our team approaches each claim of the paranormal by conducting thorough, standardized research in an attempt to seek out logical explanations for claims being made.

TSRG members take every precaution to protect our clients personal information and privacy. We show up at each investigation in unmarked vehicles and each team member will provide proof of identification prior to starting an investigation. All details regarding our visit are worked out and documented with our clients prior to our arrival.

Once TSRG arrives at your location, we conduct a walk-through with our clients and document all areas where claims of paranormal activity have occurred. During this time we will request any special instructions from our clients with regards to where we can and cannot go on your property.

We will then conduct interviews with all witnesses if they are available and willing to talk about their experiences. We then deploy all of our equipment and conduct a complete and thorough investigation.

From start to finish, every aspect of our investigation is documented.

Once we have completed the onsite investigation, our team will review all of the data captured during our visit. We usually require 7—10 days to review the data, research property history, and finalize our report.

At the end of our investigation our clients are presented with a thorough report of our findings as well as any data captured to support those findings.
